REGULAR MEETING OF THE BIG STONE COUNTY BOARD October 20, 2020

The Big Stone County Board of Commissioners met in the courtroom at 8:30 AM on Tuesday, October 20, 2020. Chairman Athey called the meeting to order with Commissioners Backer, Klepel, Olson and Sandberg present. Also present were Dillon Dwyer of the Ortonville Independent, County Engineer Todd Larson, Maintenance Supervisor Darby Karsky, Coordinator Pam Rud, County Attorney Joe Glasrud and County Auditor Michelle Knutson. HR Director Dawn Gregoire was participating via TEAMS. The Pledge of Allegiance followed.

There were no items for the scheduled work session.

Motion by Olson, seconded by Sandberg and carried to approve the minutes of the October 6th regular board meeting.

Motion by Backer, seconded by Klepel and carried to approve the agenda. Jeff Klages arrived at the meeting.

Engineer Larson reported that the County has received the final FEMA payment for the 2019 spring flooding.

There will be an informal landowner meeting for County Ditches 5 and 21 at the November 3rd board meeting to discuss potential repairs and/or changes as part of the Highway 12 project.

Motion by Olson, seconded by Sandberg and carried to authorize the sale of the 1986 Oshkosh as requested by Maintenance Supervisor Karsky.

Larson and Karsky provided an update on the options for future cleanouts of coontail on County Ditch 2. Karsky presented an idea of using a landscape rake for future cleanouts. This was tabled until there is need for a cleanout and will be reevaluated at that time.

Chairman Athey adjourned the meeting at 9:14 AM.
